TONI&GUY YEN YOUNG AUSTRALIAN ART AWARD TERMS AND CONDITIONS

1. Information on how to enter and prizes form part of these Conditions of Entry. Registration for and/or participation in this competition is deemed acceptance of these Conditions of Entry. Acceptance of these Terms and Conditions is a condition of entry.
2. Entry to this competition commences at 9.00 am August 31, 2011 and closes at 5 pm on 16 December, 2011 AEST.
3. Entry to this competition is open to Australian residents who are female and aged between 18 and 35 years old on 16 December, 2011 AEST. Employees, suppliers, agencies and partners associated with this promotion (and their immediate friends and family) are ineligible to enter. Artists who have previously exhibited at Gaffa are eligible to enter this competition.
4. To enter the competition entrants must visit the *Yen* Magazine website, register as an entrant, upload an image of their artwork, fill in the entry form online and submit it to the Toni&Guy *Yen* Young Australian Art Award presented by Gaffa.
5. The Promoter reserves the right to refuse any entry which is inadequately prepared for display. Artwork must meet the following specifications:
 - (ii) The uploaded image should be 300dpi jpeg format, and must not exceed 4MB file size.
 - (iii) All entries must be original work of the exhibitor and must have been completed no earlier than a year prior to the final closing date.
 - (iv) The uploaded image must be a 2D artwork in any medium excluding photography.
 - (v) Only one entry per person is permitted.
 - (vi) Artworks consisting of multiple pieces may qualify as single entries, as long as these strictly meet size restrictions, and photographs of the work as a whole are submitted.
 - (vii) Hanging works not to exceed 2m² in area, in any dimension.

- (viii) Works consisting of two or more parts may be considered, but must fall within this size restriction. This size includes frame.
 - (ix) A maximum weight restriction of 10kg will be placed on hanging art works.
 - (x) All painting must be dry, framed or professionally presented, wired and ready for hanging with no projections on the canvas that could cause damage to other works. Frames or hanging devices requiring repair work will be rejected.
6. Entrants must own copyright of the uploaded image.
 7. The promoter reserves the right to vet all entry images prior to them going live on the website and reserves the right to remove any entries at any time in their absolute discretion. The promoter is not responsible for any entry images uploaded to the site and visitors to the site view it at their own risk.
 8. The Promoter reserves the right, at any time, to verify the validity of entries and entrants. Without limitation, entrants agree to provide identification to the Promoter upon request. The Promoter's decision in relation to all aspects of the promotion is final and no correspondence will be entered into.

Judging and Finalist Selection

Only 20 SELECTED finalists will be listed on *Yen* Magazine's www.yenmag.net website from January 16, 2012 and will be contacted by phone or email. Please do not contact *Yen* magazine to see if your artwork has been selected.

Gaffa will host a group exhibition of finalists' artwork from March 8, 2012 to April 2, 2012.

Please see delivery terms and conditions below.

If, for any reason a finalist is not able to deliver their artwork for the finalists exhibition at the Gaffa, then the Promoter may at its discretion:

- (i) disqualify the finalist (who will then forfeit all their prizes) and/or
- (ii) use only the other finalists in the finalists exhibition and/or
- (ii) select another entrant as an additional finalist

Finalists must confirm with *Yen* Magazine that they have received notification of their inclusion within one week of this date, or another finalist will be chosen in their stead. If your artwork is not on the selected list then it has not been selected.

All entrants consent to the use of their name and their artwork for the purpose of promoting, publicising or marketing this competition including any outcome.

The work selected by the Judges is final, and no correspondence will be entered into regarding their decision. In the event of a dispute regarding the interpretation of these Terms and Conditions of Entry, the decision of the Judges will be final.

The Winner

The Winner will be announced at the launch of the Finalists' Exhibition at Gaffa on 8 March, 2012.

The Winner's name will be published on the site and in *Yen* Magazine and on the *Yen* Magazine website.

Delivery and Collection of Finalists' Artwork

Finalists must organise the delivery of their art works, whether in person, via post or courier, to Gaffa, 281 Clarence St, Sydney NSW 2000, between the dates of Tuesday 28th February and Friday 2nd March between 11am and 5pm.

Freight/courier costs must be at the artist's expense.

All works must be correctly packaged and packaging should be of a quality to allow for re-use and the safe return of the works.

Return freight/courier/post stickers must be included.

Artworks will be available to collect from Gaffa - from Wednesday 4th – Saturday 7th April 11am – 5pm. Artists who have organised for their works to be returned via post will have their works POSTED during this time and can expect for their work to be RECEIVED in the week following.

GAFFA WILL NOT BE RESPONSIBLE FOR ANY WORK THAT IS NOT COLLECTED BETWEEN THE ABOVE DATES.

Insurance

Insurance of artwork is the responsibility of the entrant. The Promoter and Gaffa accept no responsibility for loss, theft or damage of artwork incurred during freight/transportation to and from Gaffa.

Copyright

The Promoter and Gaffa reserve the right to photograph the exhibited works for the purpose of documentation and promotion in any medium and on any other promotional material indefinitely.

The information entrants provide will be used by the Promoter for the purpose of conducting this promotion and, in the case of the winner and finalists, in relation to the conduct of the Promoter's marketing and publicity campaigns. The Promoter may disclose Entrant's personal information to agents to assist in conducting this Promotion, to communicate with Entrants and to State and Territory gaming authorities.

Sale of Artworks

Finalists are invited to sell their artwork through Gaffa Gallery.

Artists that would like to sell their work must nominate a price, including GST. Artworks not for sale must be marked as such (NFS).

Gaffa takes a 25%+GST commission for any work sold. If the buyer intends to purchase a work and has not liaised with the artist their details will be forwarded to the artist via gallery staff. Gallery staff will advise the buyer to collect bought works from the Wednesday after the exhibition ends.

Gaffa requires an invoice for any work sold. Payment to the artist can be expected one month from bump-out and once the purchaser has paid in full. A tax-invoice including contact details & ABN number from the artist to the gallery must be provided to receive payment for works sold.

Prices supplied to Gaffa should be retail and allow for GST. GAFFA'S commission is (25%+GST) For example a \$100 artwork sale = \$25 Commission + \$2.50 GST. Gaffa would receive GAFFA \$27.50 and the artist would receive \$72.50.

Artists without an ABN will have to supply a Statement by Supplier form from the Australian Taxation Office (Available from the ATO website www.ato.gov.au)

Please note the artist must organize own packaging of any work sold at bump-out.
